We use a third-party provider, Wix, to deliver our newsletters. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our e-newsletters.

For all visitors to Corazon Health's website, we use Wix Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone.

How long we keep your data for:

In line with data protection principles, we only keep your data that you submit via Contact Form for as long as we need it for.
